An eligible member must only swipe their OWN membership card at the member's promotional terminal.</li> <li>2. An eligible member must swipe their West HQ Loyal card at the Member's Promotional Terminal to receive their entry ticket during the promotional period.</li> <li>3. Once eligible member has swiped during at the promotional terminal, they must place ticket in the designated barrel provided.</li> <li>4. Each member may swipe every hour from 10am every day during the promotional period.</li> <li>5. Member Swipe entries in the barrel, will reset after every draw on Thursdays. Members who receive an entry ticket during or after the draw will be in the following draw date.</li> <li>6. Entries will close at 6:59pm on each draw night.</li> <li>7. Please note that NO Tickets can be purchased, and Visitors do not receive any tickets.</li> <li>8.
