Terms and Conditions

Promoter	CUB Pty Ltd (ABN 76 004 056 106), Level 20, 2 Southbank Blvd, Southbank VIC 3006.
Who can enter?	Only Australian residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Competition Period	02/10/2020 to 01/11/2020.
Venue	The competition will run in West HQ, 33 Railway Street, Rooty Hill NSW 2766.
Qualifying Purchase	1 schooner of Great Northern Super Crisp.
Entry instructions	To enter, you must, during the Competition Period after making a Qualifying Purchase from the Venue: (a) receive an entry form from the Venue (subject to stocks remaining); and (b) fully complete the entry form and put it in the entry box at the Venue.
How many winners will there be and how will they be chosen?	There will be 1 winner determined in respect of this competition. A draw will be held at 12pm on 02/11/2020 at the Venue. The first valid entry drawn randomly from the entries received during the Competition Period will win the prize. What can I win?	There is 1 prize available. The prize is a GNBC Tinnie with trailer and engine valued at \$8,000. The prize does not include registration, insurance or any other on road costs. Entry

- 2 Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. Entry forms from any other competition cannot be used for this competition, and are void if copied, forged, stolen or interfered with. Where relevant, submitted entry forms are the Promoter's property. If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product is defective). Prizes

- (e) travel dates and specified travel exclusion periods;

General

- 23 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 24 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant). Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
- 25 This competition is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Facebook, Instagram and Twitter. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.
